RULES

BE SURE TO LIST THE ITEMS YOU WILL BE SELLING OR DISPLAYING IN YOUR BOOTH SPACE. THE CHAMBER OF COMMERCE RESERVES THE RIGHT TO REFUSE SPACE ON THE BASIS OF DUPLICATION OR PRODUCT. THIS IS FOR EVERYONE'S BENEFIT.

THERE IS A DUPLICATION RULE IN PLACE FOR ALL FOOD VENDORS. VENDORS WILL BE ALLOWED TO SELL PRODUCTS WHICH ARE NOT PRE-APPROVED BY THE CHAMBER OR ALREADY APPROVED FOR ANOTHER VENDOR FOR SALE. DUPLICATION RULE ALSO IN EFFECT FOR INFORMATIONAL TYPE VENDORS (THOSE GETTING LEADS). IT IS VIRTUALLY IMPOSSIBLE FOR US TO PLACE A DUPLICATION RULE ON CRAFT ITEMS.

YARD SALE TYPE ITEMS ARE NOT ACCEPTABLE. WE ARE ONLY ACCEPTING APPLICATIONS FOR FOOD/BEVERAGES, HANDMADE ITEMS, NEW ITEMS AND TRUE ANTIQUES.

THIS FESTIVAL IS A FAMILY EVENT AND VENDORS SHOULD EXERCISE CARE IN CHOOSING THEIR DISPLAY ITEMS TO MAKE SURE THEY ARE APPROPRIATE FOR CHILDREN TO SEE. IF WE FIND PRODUCTS WE FEEL ARE NOT APPROPRIATE OR THAT WE FEEL PRESENT A DANGER, WE RESERVE THE RIGHT TO HAVE YOU REMOVE THE PRODUCT(S) FROM DISPLAY.

BEVERAGES AND FOOD FOR GIVEAWAY ARE PROHIBITED AS IT TAKES AWAY PROFITS FROM OUR FOOD VENDORS. VENDORS ARE NOT ALLOWED TO HAVE PATRONS PLAY GAMES AT THEIR BOOTHS FOR PRIZES SINCE THE CHAMBER RELIES ON GAMES REVENUES AS PART OF OUR FUND RAISING EFFORTS. THIS DOES NOT PERTAIN TO RAFFLES FOR QUILTS, ETC. NO VENDOR IS ALLOWED TO DO A 50/50 OR ANY OTHER CASH DRAWING.

ALCOHOLIC BEVERAGES ARE NOT ALLOWED IN THE PARK. ANYONE VIOLATING THIS RULE WILL BE ORDERED TO LEAVE THE PARK IMMEDIATELY BY THE DELMAR POLICE DEPARTMENT.

ANY INDIVIDUAL OR BUSINESS SELLING FOOD ITEMS MUST MAKE APPLICATION TO THE SUSSEX COUNTY HEALTH DEPARTMENT FOR A PERMIT. THE HEALTH DEPARTMENT WILL VISIT THIS FESTIVAL TO MAKE SURE ALL VENDORS ARE PERMITTED TO SELL FOOD. FOOD VENDORS MUST DISPLAY THEIR PERMIT IN A VISIBLE LOCATION WITHIN THEIR BOOTH.

YOU MUST PROVIDE YOUR OWN TABLES, CHAIRS, HEAVY DUTY ELECTRICAL CORDS, AND SHADE UMBRELLAS OR ANY OTHER SUPPLIES YOU NEED TO OPERATE YOUR BOOTH.

THERE WILL BE ONE ORGANIZATION OR BUSINESS PER BOOTH. MULTIPLE ORGANIZATIONS OR BUSINESSES CANNOT SHARE ONE SPACE. VENDORS MUST FIT THEIR ENTIRE DISPLAY INSIDE THE SPACE REQUESTED. ANY SET UP OUTSIDE THE AREA WILL NOT BE ALLOWED AS IT INTERFERE'S WITH FOOT TRAFFIC PATTERNS.

PLEASE REPORT TO THE CHECK-IN TABLE LOCATED AT THE PAVILLION BEFORE SETTING UP YOUR BOOTH SO A VOLUNTEER CAN SHOW YOU WHERE YOUR BOOTH IS LOCATED. SET UP TIME IS 8:00 AM - 10 AM. ALL FEES AND RESPONSIBILITY RELEASE AND IDEMNIFICATION FORMS MUST BE SUBMITTED BEFORE SET-UP. PLEASE DO NOT CHECK IN PRIOR TO 8AM.

EARLY TEARDOWNS ARE NOT PERMITTED UNLESS THE CHAMBER CLOSES THE FESTIVAL. YOU NEED TO MAKE SURE YOU HAVE PLENTY OF PRODUCT TO LAST THROUGHOUT THE DAY.

IF YOU MUST CANCEL FOR ANY REASON YOUR BOOTH FEE WILL BE REFUNDED TO YOU IF YOU NOTIFY US PRIOR TO MAY 21ST, 2010.

A \$25.00 FEE WILL BE CHARGED TO ANY VENDOR WHO'S CHECK IS RETURNED UNPAID FOR ANY REASON AND VENDOR WILL BE PLACED ON CASH ONLY BASIS OR WILL NOT BE ALLOWED TO PARTICIPATE IN FUTURE EVENTS.

ALL VENDORS WHO ARE PAID FOR JUNE 5TH WILL NOT BE REQUIRED TO PAY AGAIN FOR THE JUNE 26TH RAIN DATE AND WILL HAVE FIRST OPTION TO PARTICIPATE WITH APPROVED PRODUCT.

PARTICIPANTS WHO OFFER ACTIVITIES INVOLVING PHYSICAL GAMES OR OTHER PHYSICAL ACTIVITY MUST PROVIDE PROOF TO THE CHAMBER OF COMMERCE OF THEIR OWN LIABILITY INSURANCE COVERAGE.

BE IT KNOWN THAT I WILL ASSUME ALL RESPONSIBILITY FOR MY PERSONAL OR MY GROUP’S BELONGINGS AND FOR ANY INJURIES WHICH MAY OCCUR AS A RESULT OF MY/OUR PARTICIPATION IN THE “DELMARVA’S DAY IN THE PARK FESTIVAL”. I/WE WILL NOT HOLD THE GREATER DELMAR CHAMBER OF COMMERCE OR ITS INSURANCE COMPANIES RESPONSIBLE FOR ANY INJURIES OR EXPENSES WHICH MAY OCCUR DURING MY/OUR PARTICIPATION.
